

Sec. 70-7 Parking Prohibitions:

- (a) No Parking of any motor vehicles in the Sanitary District is permitted.
- (1) Exceptions to prohibited parking within the Sanitary District:
- Gogebic St.-from Huron St. to Superior St. (Hwy45/32)-Parking east side
 - Gogebic St.-from Superior St. to Anderson St.-Parking east side
 - W. School St.-from Anderson St. to Superior St.-Parking east/west side
 - W. School St.-from Hwy 45 to Huron St.-Parking east/west side
 - E. School St.-from Superior St. to Erie St.-Parking east/west side
 - E. School St.-from Erie St. to School Dr.-Parking east side
 - E. School St.-from School Dr. to School-Parking west side
 - Erie St.-from Gogebic St. to W. School St.-Parking north side
 - Erie St.-from W. School St. to E. School St.-Parking north/south side
 - School Dr.-from E. School St. to W. School St.-Parking north/south Side
 - Superior St. from Gogebic St. to East St.-Parking north/south Side
- (b) *Parking prohibited during certain hours.* No person shall park, stop or leave standing any vehicle except temporarily for the purpose of and while engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a license operator so that it may be moved promptly in case of an emergency or to avoid obstruction of traffic upon the following locations or highways, at the time indicated, when official traffic signs restricting and limiting such parking are posted on the portion of those locations or highways, or at the corporate limits of the town as specifically provided by law:
- (1) *Generally.* For a period of time between the hours of 2:00 a.m. and 6:00 a.m., except physicians on emergency calls, on any street or highway in town.
- (c) *Temporary parking in restricted areas.* If temporary parking is needed notify the town office or police department with the following information:
- (1) The location of the vehicle;
 - (2) License plate; and
 - (3) Vehicle description
- (d) *Parking during snow emergency.*
- (1) *Declaration of snow emergency.* The town board hereby declares that an emergency may exist in the town and such emergency shall be declared during the period of a snowstorm or immediately thereafter, whenever there exists a serious public hazarded impairing transportation and public health, safety and welfare as determined by the town chairman or his/her designee.
- a. *Notice of emergency.* The town chairman, or his/her designee, may proclaim the state of emergency through the press; radio or other public means of communication and may designate and authorize law

enforcement officials and snow removal personnel to inform the citizenry of the existence of the emergency.

- b. *Duration of emergency.* Snow emergency parking regulations shall commence two hours after the original broadcast for a period of 24 hours or until such earlier time as snow-removal operations have been declared completed by the town chairman, or his/her designee.
- c. *Parking prohibited during emergency.* No person shall park any vehicle on a street, road, highway, public way, or public parking lot during the period of a snow emergency.
- d. *Authorization of erection of no parking signs.* Pursuant to the provisions of Wis. Stats. § 349.13, the director of public works is authorized to erect permanent official traffic signs at or reasonably near the corporate limits of the town on all state and county trunk highways and connecting highways, informing motorists that parking is prohibited upon any street in the town during the existence of a snow emergency.
- e. *Removal of vehicles.* The director of public works, his/her designee, or any traffic officer is hereby authorized to cause the removal of vehicles parked in violation of this section. The removal may be by or under the direction of the director of public works, his/her designee, or any traffic officer, or may be contracted for removal by a private service. In addition to other penalties provided in this section, any charges related to moving, towing, or storage of the vehicle shall be the responsibility of the owner or operator of the vehicle.

(2) No parking on designated area for snowplow turn around, as signed.

(e) No Parking of any motor vehicles on roads to boat landings except as follows:

- (1) Panfish Landing (*Thunder Lake*)-Parking east/west side
Sawmill Landing (*Seven Mile Lake*)-Parking north/south side
VanBussum Lane (*Long Lake*)-Parking north/south Side
E. Big Lake Loop Rd. (*Magoons*)(*Thoroughfare-Big Lake*)-Parking south side
Hwy X Rd. (*Medicine Lake*)-Parking North/south side
Lake Dr. (*Maple Lake*)-Parking west side
Chicken in the Woods (*Big Stone*)-Parking north/side
Halverson Rd. (*Rangeline*)-Parking east/west

(f) Enforcement. A constable of the town or any other traffic officer may issue a citation for a forfeiture penalty in violation of this section. A constable of the town or any other traffic officer is authorized and empowered to remove or have such vehicle removed to a position where parking is permitted. (Ord. 3-10-2009)
