**SECTION I - TITLE AND PURPOSE.**

The title of this ordinance is the Town of Three Lakes Comprehensive Plan Ordinance. The purpose of this ordinance is for the Town of Three Lakes, Oneida County, Wisconsin, to lawfully adopt a comprehensive plan as required under sec. 66.1001(4)(c), Wis. Stats.

**SECTION II - AUTHORITY.**

The Town Board of Supervisors of the Town of Three Lakes, Oneida County, Wisconsin, has authority under its village powers under sec. 60.22, Wis. Stats., its power to appoint a town plan commission under sec. 60.62(4) and sec. 62.23(1), Wis. Stats., and under sec. 66.1001(4), Wis. Stats., to adopt this ordinance. The comprehensive plan of the Town of Three Lakes must be in compliance with sec. 66.1001(4)(c), Wis. Stats., in order for the town board to adopt this ordinance.

**SECTION III - ADOPTION OF ORDINANCE.**

The Town Board of Supervisors of the Town of Three Lakes, Oneida County, Wisconsin, by this ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the Town Board present and voting, provides the authority for the Town of Three Lakes to adopt its Comprehensive Plan under sec. 66.1001(4), Wis. Stats., and provides the authority for the Town Board to order its publication.

**SECTION IV - PUBLIC PARTICIPATION.**

The Town Board of Supervisors of the Town of Three Lakes has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by sec. 66.1001(4)(a), Wis. Stats.

**SECTION V - TOWN PLAN COMMISSION RECOMMENDATION.**

The Plan Commission of the Town of Three Lakes, by a majority vote of the entire commission, recorded in its official minutes, has adopted a resolution recommending to the Town Board of Supervisors of the Town of Three Lakes the adoption of the Town of Three Lakes Comprehensive Plan, which contains all of the elements specified in sec. 66.1001(2), Wis. Stats.

**SECTION VI - PUBLIC HEARING.**

The Town of Three Lakes has held at least one public hearing on this ordinance, with notice in compliance with the requirements of sec. 66.1001(4)(d), Wis. Stats.

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision of application, and to this end, the provisions of this ordinance are severable.






### SECTION IX - EFFECTIVE DATE.




